- Must be willing to travel weekly to two to three (2-3) different clinical locations to provide clinical services & work collaboratively with parish partners at both locations.
- Contribute knowledge and understanding to the staff in areas of specialization. Attend and participate in regular staff meetings, trainings, and consultation teams.
- May serve as an Assessor for the Offices of the Tribunal, conducting interviews and writing reports for persons seeking an Annulment.
- Uphold Catholic social teachings.
